I. **TIME COVERED:** 1730H-1800H, April 20, 2025

II. **VENUE:** Brgy Tajao, Pinamungahan

III. **MISSION:**

In line with the mandates of the PCGA is the maritime safety and security specifically safety of life operation.

IV. **CHRONOLOGICAL EVENTS:**

At around 1730H PCG and 202nd PCGA members and its aspirants were on shoreline patrol at Brgy. Tajao, Pinamungahan, we encountered a jet ski floating on a capsized position with three (3) individuals overboard. They were identified to be Kevin Fajardo 15 years of age, Caesy Palaw 18 years of age and Bryle Ruiz 14 years of age all residents of Pinamungahan. We immediately approached the victims, assessed the situation, calm the victims and provided them with the life ring and life jacket. We pulled the victims aboard the rubber boat one by one as none of them were injured during initial evaluation and proceeded to safely bring them to the shoreline. The jet ski was being pulled along as well during this transit. Before letting them go, we did a final assessment of the victims for any injuries or body pains that might be from the incident thereafter we finally disembarked and leave the

victims safe and in good condition. Members that were in coordination during this incident from the PCG were PO3 Winston D Nuico PCG, PO3 Robin Jasper M Nerpio PCG, and PO2 Sherwin C Silvano PCG all from the Toledo City Sub-Station. The whole event ended about 1800H.
